**UPDATES**

- **CP FEDERAL SQUARE GALLERY** – Co-Chair Curtis and Burtch  
Curtis updated commission that moving forward the Jackson School for the Arts will be managing the CP Federal Square Gallery. At this time JSA plan to create new displays four times a year. She will update the commission when there is confirmation of plans and gallery committee formed. JPAC is interested in having a representative on the gallery committee.
- **FUNDING** – Sullivan, Meyer-Jackman  
Sullivan reported that she did an extensive review of JPAC funding balance. At this time JPAC has \$9,101.39 from the Jackson Community Foundation for Sculpture Initiative and an additional \$8,332.00 in account.
- **PROJECTS**  
**SCULPTURE INITIATIVE** – Chair Harrison, Co-Chair Curtis, Morse.  
Chair Harrison stated that MSI will be installing in April. MSI will notify her of exact date soon. Locations have been designated. Contact has

been sent to the city attorney for approval. Meyer-Jackman stated that the contract had been pre-approved after initial meeting with MSI in 2016. Sullivan to follow up on current status of contract and approval of locations by the city manager.

Total cost of the project in accordance with the contract: \$7650.00

Discussion of marketing and final steps of project as well as inviting Jackson Anchor Initiative members to a special tour of all sculptures.

McClellan to assist in creating a Walking Tour Map of Sculpture. Meyer-Jackman suggested contacting former commissioners Troxel and Dumistra for finding of previous sculpture maps.
