Notice is hereby given that the following additional information and changes shall become part of the specifications of the above referenced contract. You are to acknowledge the addenda on the Proposal Sheet.

1. The wood pole fit up on Jackson St will be to the pole on the northeast corner for Jackson St at Euclid St. The boring under Francis St will be eliminated. A boring under High St will be added. It will connect to the hand hole at station 98+00 to the hand hole at station 99+60. The next wood pole fit up will be on the east side of Merriman St just north of the MLK Equality Trail. The conduit between the light at about station 120+20 to the light at about station 121+90 will be eliminated. The wood pole fit up about station 126+50 shall remain as shown in the plans.
