#### 2. Meetings (MPEA requires four meetings annually)

The City Planning Commission met nine (9) times in 2020. This meets the requirements of the MPEA.

#### 3. Master Plan Review

The City and its various boards and commissions continue to work towards the vision and goals established in the Master Plan adopted in 2016. No amendments were made to the Master Plan in 2020.

April of 2021 will mark the fifth year since the Master Plan was adopted by City Council. It is recommended that the Planning Commission review the Master Plan and either reaffirm or update the Master Plan as necessary in 2021.

- CUP Request: 406 S. Blackstone; applicant requested a Conditional Use Permit to operate the MyPlace Resource Center at 406 S. Blackstone St. Commission approved with conditions on 6/3/2020.
- Mural Request: 145 W. Pearl St; Applicant requested to install a mural on the west-facing façade. The mural application was recommended for approval by the Public Arts Commission. Commission denied the request on 7/01/2020
- Conditional Use Permit Request: 123 Marshall St; applicant requested a Conditional Use Permit
  to use the former church as office space and a center for "community outreach and
  programming." Commission approved with conditions on 8/12/20.
- Conditional Use Permit Request: 432 Wildwood Ave- applicant requested a Conditional Use Permit to use the former residence/office building as a twenty-four (24) hour "Engagement Center" providing short term crisis intervention for individuals. Commission approved with conditions on 11/17/20.

<sup>\*</sup>The majority of site plans proposed within the City of Jackson are reviewed administratively, with select reviews done by the Planning Commission based on conditions stated within the Zoning Ordinance.

- **7.** Actions by Legislative Body (actions taken by the legislative body related to planning and development)
  - In 2020, the Jackson City Council approved transportation-related projects including street reconstructions on Franklin St and Wellworth St, resurfacing of Chalet Terrace St, and the sewer reconstruction on Elmdale Dr.
  - The City Council approved ordinance amendments related to Marihuana Facilities within the city and approved conditional licenses for new retail and growing facilities. The City is now accepting applications on a rolling basis until all licenses have been granted.
  - The City Council also created the MLK Corridor Improvement Authority in hopes of bolstering efforts to revitalize and encourage redevelopment of the commercial corridors along S. Martin Luther King Jr. Drive and Prospect St.
- **8. Zoning Map** (Reviewed rezoning requests to analyze potential development trends)
  - There was only one (1) rezoning request in 2020. The location of the parcel was adjacent to a larger-scale development which has changed and expanded a number of times in recent years.
